Eligibility Criteria of players for Selection Trials:

In this context, it is requested to kindly send the outstanding badminton players of your respective university as per the following eligibility criteria:

1. Only those Badminton Players are allowed who are eligible as per the FISU eligibility guidelines.
2. One University can send three best singles players and two doubles best pairs in Men Section and Two Singles players and one doubles players in Women Section
3. Only those badminton Players are eligible for selection trials who has actually participated in the All India Inter Zonal Inter University Badminton Championship 2017-18 held at KIIT University, Bhubneshwar and their teams reached up to minimum Quarterfinal stage during the above said competition.

Or

4. Those players are also eligible to participate in single or in doubles according to the following BAI Ranking in U-19 Junior/Senior on 30.05.2018:
 - (i) Singles-upto 25 Rank
 - (ii) Doubles upto 10 Rank
 - (iii) Mixed Doubles upto 10 Rank
5. Those players are also eligible who are going to take admission in the under graduate courses (subject to the eligibility)
6. **Trial fee is Rs. 1000/- per player for selection.**


Further you are also requested to direct your players to bring the following documents:

1. Original passport

2. Eight passport Size Photographs
3. Eligibility Proforma with latest I.Card duly signed by the Director Sports of respective university
4. Sports Kits/Equipments and other necessary belongings with them.

No TA/DA will be paid to the players by this university for appearing in the trial. However the university shall provide the accommodation only for night stay at University Hostels for Girls and Boys separately, free of charge.
